- limao_handbook_pta.do: STATA do file that replicates the empirical results in the chapter

Instructions for replication

- Open Replication_limao_handbook_pta.zip and unzip by dragging out the limao_handbook_pta folder
- Open \program\limao_handbook_pta.do with STATA and fill in the directory you downloaded the zip file to in line 14. For example, if you download to C:\Users\replicate line 14 would be

```
global master "C:\Users\replicate"
```

- The program uses 4 user-written commands that do not come with STATA by default (estout, outreg2, reghdfe, rowsort, and tabout). If you do not have this commands installed or are not sure you have the most updated versions, we recommend you install them by uncommenting lines 21-27
- After these steps you can run the do file. The program takes 12 minutes to run in an 8g ram laptop. All the output will be saved in the \output directory

Output files

- The program limao_handbook_pta.do will generate all the regression output, figures, summary statistics included in the chapter and save them in the folder \output.
 - tab_sum_1.csv: Naive gravity summary statistics (for Table 2)
 - tab_sum_2.csv: Structural gravity summary statistics (for Table 2)
